Thank you for your donation to Frisco Family Services Center, the only non-profit social service agency in Frisco that provides emergency assistance to low-income households and families in crisis. Your support is greatly appreciated and needed now more than ever.

Generous contributions from FFSC friends, partners and sponsors like you, enabled us to accomplish the following this past year:

- 1,089 client families served (3,508 individuals)
- 315,244 pounds of food distributed from the food pantry
- \$168,503 in financial aid toward rent/mortgage, utility or medical assistance provided
- 6,500 critical service/information referrals made
- 254 Fisd students received school supplies, clothing, shoes and haircuts
- 173 clients received Thanksgiving food baskets
- 626 children (and their parents) and seniors received holiday gifts

We also provide clients with gasoline vouchers and the opportunity to learn new skills through our adult education programs. Furthermore, we awarded three \$4000 scholarships to graduating Fisd seniors and implemented a summer lunch program for children.
